It was heartening to report that the proposed improvement to the Memorial Hall was gaining momentum. The Hall Management Committee has been established and grants have been secured to meet the cost of £250,000.

She referred to the loss of two Councillors during the year – Cllrs Gwion Hallam and Rosalind Jones, both of whom had been very industrious during the short period they had been on the Council.
