Cynllun Datblygu Lleol/ Local Development Plan.

Cafwyd gopi o Gynllun Datblygu Lleol ar y cyd Gwynedd a Mon ac anfonwyd gopi electroneg i bawb oedd gan adnodd cyfrifiadur, gyda rhai eraill yn derbyn copi caled. Teitl y cyhoeddiad oedd "datblygu'r Weledigaeth, Prif Amcanion ac Opsiynau Strategol". Os ydych am weld copi. Cysylltwch a Chlerc y Cyngor Cymuned (manyllion ar y wefan www.felinheli.org) neu ewch i wefan Cyngor Gwynedd). Y ddogfen derfynol fydd yn diffinio faint o ddatblygiadau fydd angen yng Ngwynedd erbyn 2026 ac yn lle fydd y rhain, Bydd wedyn yn sail i ddynodiadau tir manwl ar gyfer tai, cyflogaeth a hamdden.

Arweinwyd y drafodaeth gan Cyng Sian Gwenllian ac eglurodd gynnwys y ddogfen. Cwestiynwyd yn gyntaf ar ba sail y daethpwyd at y ffigyrau oedd yn cael eu cynnig yn yr opsiynau ar gyfer NIFER o unedau tai. Rhagwelwyd twf mewn angen ar draws Gwynedd rhwng 3 a 11% mewn nifer tai dros y 15 mlynedd nesaf. Ond nid yw'n glir ar ba sail y daethpwyd i'r casgliadau yma. Derbyniwyd y bydd rhaid cael tai newydd yng Ngwynedd ac fod angen am dai i bobl leol. Mae un opsiwn yn y ddogfen yn canolbwyntio twf a'r Dinas

Bangor ac 'roedd aelodau'r Cyngor yn ofni y byddai'r opsiwn yma yn niwidiol iawn i'r Felinheli ac fod peryg i'r pentref gael ei foddi gan dai newydd. Teimlwyd y byddai hyn yn gyfystyr a trefoli ardal wledig gan roi straen ar ein diwylliant a'n iaith. Mae'r iaith dan fygythiad yn barod gydag 70% yn ei siarad; gostyngiad dros y blynyddoedd. Nodwyn fod un datblygiad mawr ar y gweill ger yr ysgol fel rhan o'r Cynllun Unedol ac fod cae arall gerllaw wedi ei glustnodi ar gyfer ei ddatblygu. Dywedwyd hefyd fod nifer o ganiatadau cynllunio yn bodoli yn barod ond heb eu gweithredu. Yr angen yn Y Felinheli yw tai i bobl ifanc, tai ar rent a thai llai i bobl oeddrannus sydd efallai yn byw mewn tai rhent cymdeithasol 3 llofft fasa'n addas i deulu ifanc. Beth nad oes angen yw gwneud Y Felinheli yn bentref lloeren i weithwyr y trefi cyfagos.

Minutes of the meeting held on 13th Decemberr were presented and accepted as correct subject to amendments to the minute referring to the Local Development Plan. Clerk to re-set the minutes as follows:

A draft copy for discussion of the Anglesey and Gwynedd Joint Local Development Plan had been received and a copy was sent electronically to everyone that had computer facilities, whilst some others received a hard copy. The document is called "Developing the Vision, Key Objectives and Strategic Options 2. (If you would like a copy please contact the Community Council Clerk – details on www.felinheli.org). or visit the Gwynedd Council website.

The discussion that followed was led by Cllr Sian Gwenllian who explained the contents of the document. The councillors questioned how the Council had arrived at the different figures in the options for the number of housing units, It was also accepted as fact that there was a need for more homes in Gwynedd, and the need for houses for local people. One option in the document centres on the City of Bangor and the members of the Council were afraid that this option would be detrimental to Y Felinheli as there was a danger of the village being swamped with new houses. It was felt that this was tantamount to the urbanisation of a rural area by imposing a strain on its culture and language. The language is already under threat with only 70% speaking it; a decline over the years. It was noted that one substantial development was already in process near the school as part of the Unitary Development Plan and a further field nearby has been earmarked for development. It was also stated that numerous planning applications have been submitted but have not been implemented. The need in Y Felinheli is housing for young people, rented accommodation, and smaller houses for the elderly who possibly are living in rented community housing with 3 bedrooms that would be more suitable for a young family. What is not needed is to make Y Felinheli a dormitory village for workers in nearby towns.

Councillors' Report Jan 2012 HAPPY NEW YEAR TO YOU ALL

- 1) Letters requesting prices for a contract to landscape improvements on the green slope opposite Londis have been sent to two interested parties. We are eager to hear ideas and will be holding a meeting. Grant has been approved by Tidy Towns.**
- 2) Sustainable Communities Application:** Felin is one of 5 communities chosen to be part of an exciting project. Meetings are being held. I will email more details about this scheme.
- 3) Lon Las: Gwynedd Council is eager for the work to create a new piece of cycle track on the old railway track between Allt Dinas and Ffordd Caernarfon (accessing the main road near the lay-by on Ffordd Caernarfon) in March 2012. The development will need planning permission and local people will be able to voice their opinions through the planning process.**
- 4) The Urdd Committee has arranged two other events to raise the remaining £2,000.**
- 5) Drws y Coed / Tan y Maes Housing scheme.** This land is part of the Unitary Development Plan and would have to include 18 affordable houses out of 52 houses. The plan has not yet been submitted and there will be a chance for everyone to see the plans and make comments through the planning process.
- 6) Pistyll Footpath near Ffordd Brynffynnon : the work is in accordance to planning permission.**
- 7) Salt chest at the top of Snowdon Street : The Council say the bin has been relocated on the street and will not be placing a new bin.**
- 8) Kiosk at Aberpwll: its condition is deteriorating and BT accept responsibility for maintaining this as it is in a conservation area. We will continue to press for the work to be carried out.**
- 9) Speed limit signs at Aberpwll. A request has been received to either move the 30MPH signs further out of the village or for 40MPH before the 30 signs and for traffic calming.**

- 10) Lon Las near Yr Hen Orsaf (Penningtons): residents are concerned about lack of regulation on cars and cycles near the building. New road markings have been placed here.**
- 11) Y Felinheli Local Development Plan: this is being discussed at Community Council meetings at the moment. I will email more details.**
- 12) Recycling bins have been removed from Half Way at owner's request. Community Council hopes they can be relocated to car park near the Dock.**
- 13) School : I discussed community issues with Year 6 and will be returning there to develop an action plan.**

Agreed that there was no need for further housing except housing for local people. It is important to protect land for leisure and employment purposes. No development to land outside the village boundary. But Gwynedd Council will decide in the long term.

Following discussion, and for the purpose of submitting Community Council comments before the closing date set by Gwynedd Council, it was agreed to accept the plan as a response and to convey comments to Ms Nia Davies, Joint Planning Policy Unit, Gwynedd Council.

DECIDED: that the map, together with Community Council's recommendations be displayed to the public at Y Felin Sgwrsio and on the website.
